Upcoming plans for improving policies, processes and procedures

- Currently updating campus Title IX policy and procedures for faculty, staff and students to align with the newly released TIX regulations. The new policy and procedures will be implemented by August 14, 2020.
- Creating a student advisory board who will meet with administrators to take a closer look at policies, procedures and programming to increase reporting and enhance support for survivors.
- Re-apply for the [Department of Justice](#) Grant (October 2020)
 - Grant focuses on combatting sexual violence, dating violence, domestic violence and stalking. It provides funding for increased programming, events and resources and/or create a safe space on campus for survivors of sexual violence.
- Re-apply for the It's on Us grant (January 2021)
- Purchasing new tracking software for Title IX, Clery and VAWA related incidents (fall 2020)
